## Fees

Painting/Painters: $\$ 100$ per hour, $\$ 50$ ea. additional hour for facepainting only. $\$ 150$ per hour \& $\$ 65$ ea. additional for facepainting and glitter tattoos. One hour Minimum. Fees are based on one artist. One artist can paint approximately 10 to15 faces per hour depending on the intricacy of the designs that are chosen. Depending on your event and time allotted, more than one artist may be necessary, an additional fee will apply, please contact us for this quote. Be sure to book your time accordingly to avoid leaving anyone out. PLEASE do not ask us to disappoint any guests due to lack of time booked. Sometimes we have an event booked right after yours and we may not be able to stay past stop time contracted here. If you would like to extend the time booked and we are available to stay, it will be charged in half hour increments. All charges are due on the day of the event. Client must pay for a minimum of 1 hour even if Client uses Artists for less than 1 hour. In the event that a Client delays start time, full payment is still expected. Contracts that are not completed within 14 calendar days of event risk losing that date.

Travel/setup/other fees: Travel fees apply when the event is more than 1 hour or 50 miles from Washington Township, NJ (07882). Depending on your event, there may be a charge for outdoor, lengthy or difficult setup - please advise us if you think this will apply. Should a check be returned, there is a $\$ 30$ returned check fee.

## Parking

Please either leave a space open in front of the location on the street, a driveway, parking lot, or a loading dock so artist can unload equipment. The Client will reimburse artists for any parking fees that may apply.

## Indoor Setup

Bathroom facility or access to water, a minimum of $6^{\prime} \times 6^{\prime}$ space and 15 minutes of setup and take down time is required. Please ensure that location has adequate lighting but we can bring lights if necessary - please let us know.

## Outdoor Setup

We can bring our easy-up shelter, table, and chairs for no additional charge. The tent requires a minimum of $10^{\prime} \mathrm{L} \times 10^{\prime} \mathrm{W} \times 11^{\prime} \mathrm{H}$ of level space, adequate lighting, access to a rest room or water supply and a place to dispose of our painting water. Please don't water your lawn on the day of your party, or soak it heavily the previous day if possible.

Weather (for outdoor events)

For the comfort of your guests, the client should be able to provide an alternate, indoor location in the event of severe or inclement weather such as extreme temperatures, sun, rain, snow and excessive wind. If the painter has arrived at the event location and the event is cancelled due to weather, client agrees to pay half the amount contracted

## Cancellations / Refunds / Reschedule

Should you need to reschedule your event, please do so at least 7 days prior and we will make every effort to meet your needs. If you need to cancel the event, you must cancel within 24 hours of the event or you will have to pay the total contracted amount. Should our artist get sick/ have to cancel, we will find a replacement artist.

## Limitations On Artwork

Unless we are contracted for a specific private function, parties are considered public events and as such, our artists will not paint on any part of the body that is not legal to expose or anyplace they do not feel comfortable painting. In addition, Artists will not paint subject matter deemed offensive or disturbing.

## Extreme Adverse Working Conditions

Artist has the right to cease painting and leave without refunding any monies if there are extreme adverse working conditions and the Client fails to remedy the situation after it has been brought to the Client's attention. Adverse conditions included but not limited to: destructive, violent, or extreme inappropriate behavior of a child, pet or adult; illegal activities; or otherwise dangerous conditions.

## Liability Statement

While we use ONLY FDA approved, hypoallergenic cosmetic grade face painting upplies, Artist is not liable for allergic reactions to paints. People with severe known allergies or highly sensitive skin should either not participate, or have Artist perform a patch test at the beginning of the party. Client understands that darker face paints may linger and removal may be easier with mild soap, water and washcloth. For safety reasons, Artists will not paint children under 1 year old or anyone who is unwilling. For sanitary reasons, Artists will not paint anyone who is or appears to be sick or suffering from cold sores, conjunctivitis, ringworm, sunburn, eczema, any infectious skin condition or open wounds. These determinations are at the Artist's discretion. Our artists always use reasonable care, but can not be held responsible for damage to clothing or property. The Client agrees to pay for any accidents or injuries caused by pets or guests, and/or any damage to Artist's equipment or supplies caused by pets, lawn sprinklers, or guests. Under no circumstances will Artists supervise children. Their behavior and safety is the Client's and/or Parents' responsibility.

This contract does not go into effect until the $50 \%$ deposit is received; all dates and times are agreed upon by both parties as listed on page one of this contract and both parties have signed this agreement.
